*DECLARATION: In consideration of receiving, from Leash of Life Rescue, one dog of the above description, which is without warrant, I of the above name and address, hereby undertake with Leash of Life rescue, hereinafter abbreviated as LoL, that: I AGREE, throughout the duration of this fostering contract and unless superseded by an adoption contract with LoL, that the ownership of the dog remains with LoL. I AGREE to accept this dog as a household pet and provide for its general care and welfare, supplying appropriate food and fresh water, shelter, comfort, exercise and companionship and allowing the dog a reasonable amount of time to settle and adapt to its new environment. I AGREE to provide any training and socialisation necessary, either personally or through attending professional dog training classes and will use only positive reinforcement methods. I AGREE to abide by all the requirements of UK law relating to dogs and to ensure the dog wears a collar with tag containing both LoL and my own details at all times. I UNDERSTAND and accept that the microchip will be registered to LoL. I AGREE to provide LoL with regular updates on the dog's health, wellbeing, temperament and training and to complete and return any associated paperwork upon request. I AGREE not to allow the dog off lead when on walks. I AGREE not to leave the dog unattended in a public place at any time. I AGREE to inform LoL of any veterinary treatment and expenses, prior to treatment being carried out, except in the case of an emergency, where I undertake to inform LoL immediately upon the dog being taken into veterinary care or receiving emergency treatment. I AGREE not to have the dog euthanised (unless due to a medical emergency or a severe medical condition which affects the dogs quality of life, for which prior consultation and agreement must be made with LoL). I WILL inform LoL, the police and the local authority immediately, if the dog is lost or stolen and will make reasonable efforts to recover the dog. I WILL inform LoL immediately of any change of circumstances or difficulties which arise, which may result in the termination of this fostering contract and will allow LoL a minimum of 5 days to make alternative fostering arrangements.

I WILL notify LoL immediately of any proposed change of address or contact number, or of any plans to move or travel with or without the dog. I AGREE to return the dog to LoL, at any time and for any reason, upon request.

I CONFIRM that I am over 18 years of age. I AGREE that LoL has the right to remove the dog, if it is felt the dog is not being cared for correctly. I AGREE

that I have been made fully aware of all responsibilities, which I freely enter into on the signing of this agreement.
